Most of the people I talked too use the trolley various times during the week and find it to be very beneficial. Their biggest concern and complaint is that the trolley takes too long between routes which means we need to better our route optimization.



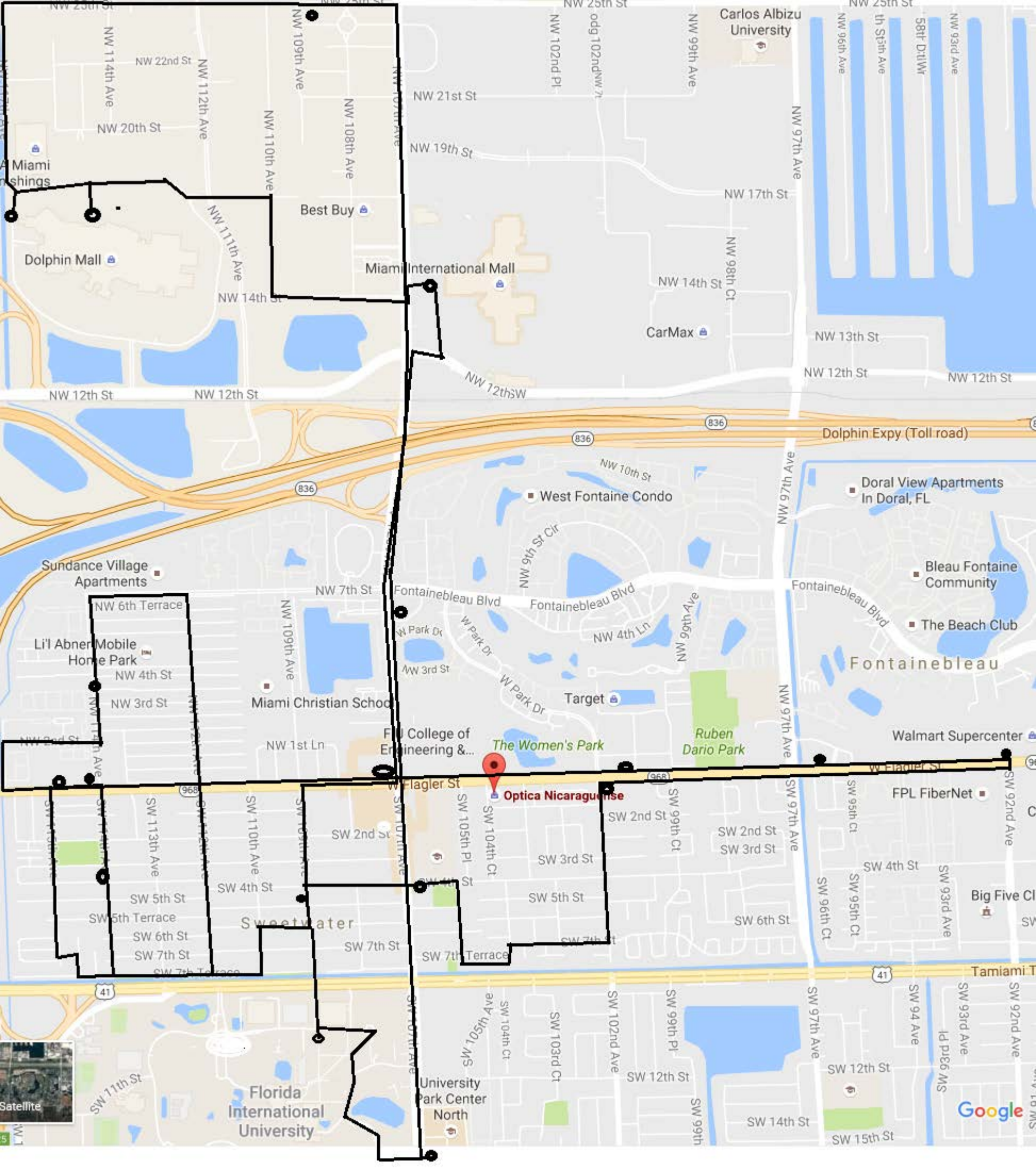
